THIS MONTH IN THE REVOLUTIONARY WAR

The Powder Alarm was a major popular reaction to the removal of gunpowder from a magazine near Boston by British soldiers under orders from General Thomas Gage, royal governor of the Province of Massachusetts Bay, on September 1, 1774. In response to this action, amid rumors that blood had been shed, alarm spread through the countryside to Connecticut and beyond, and American Patriots sprang into action, fearing that war was at hand. Thousands of militiamen began streaming toward Boston and Cambridge, and mob action forced Loyalists and some government officials to flee to the protection of the British Army.

Color Guard Report:

- The summer has been quite quiet.
- We will participate in an October musket training which will be in St. James, Missouri on October 29th.

Flag Recognition Report: Secretary Dan Evans presented a flag recognition certificate on September 11th.

Fund Raising Report: None, other than the report on the upcoming Trivia Night

Other Reports: Chaplain Steve Baldwin reported on this year's SAR Congress in Savannah, Georgia and mentioned how valuable it was. He also related a discussion he had with our President General about working toward getting applications and Supplementals through the system faster. He encouraged everyone to attend a National Congress at least once and the reasons why it would be beneficial.

Old Business:

 We discussed our options for food at the meetings. It was agreed to run a survey of all members' desires as well as bringing food into the Community Council venue, and potentially having catered meals. Members will be responsible for payment prior to the meeting if it is decided to have meals provided

New Business:

- President Jackson announced that Missouri Society President Michael Robertson will attend our October 10th meeting.
- Historian/Registrar Dennis Hahn discussed the following:
 - O House Bill 1738 was signed into law and section 227.774 designates the portion of State Highway 94 from State Highway TT to State Highway F in St. Charles County shall be designated as the "George Washington Highway". This memorial designation became effective August 28, 2022. Compatriot/Sate Representative Adam Schnelting sponsored the Bill. The Department of Transportation (MODOT) shall erect and maintain appropriate signs designating the section of Highway 94 as the "George Washington Highway". However, the costs need to be paid by private donations. The Department of Transportation is requesting a payment of \$3,200 for a total of two (2) signs. This will be on the MOSSAR Board Meeting Agenda for October 29, 2022.
 - There is planned to be a replication in 2025 of the "Marquis de Lafayette Tour of the United States in 1824-1825". There will be a possible tie to the 2025



MOSSAR Annual Meeting, which will be hosted by the Fernando de Leyba Chapter. The tour is being planned to start in February 2025 that will cover Georgia, Alabama, Louisiana, Mississippi, Tennessee, and ending in Missouri in April 2025.

- The All Saints Catholic Church Heritage Committee is planning a year-long celebration in 2023 of the 200th Anniversary (Bicentennial) of the Church. They want an SAR grave marking for Patriot Etienne Bernard with a plaque similar to the kind that the DAR places on Patriot graves. Patriot Bernard is buried in the All Saints Church Cemetery. Patriot Bernard participated in the Battle of Fort San Carlos. I confirmed to the Committee that the SAR will obtain a plaque for the grave of Patriot Etienne Bernard. The Committee will arrange for the plaque to be installed in concrete at the grave site. Compatriot Hahn will finalize the design of the plaque and order the plaque. The cost of the plaque will be paid by two members of the Church: Trish Walther and Diane Valentine. The Chapter may need to also participate with the cost.
- Compatriot Hahn informed the Chapter of the future Theodore Roosevelt Presidential Library, which will house a museum and facility for records of Roosevelt, the 26th President of the United States. It is to be constructed at a site west of Medora, North Dakota, near Theodore Roosevelt National Park. Construction is planned to begin in 2023. They plan to have a Grand Opening on July 4, 2026. With President Theodore Roosevelt being an SAR Member and having signed the United States Congress Act Chartering the NSSAR on June 9, 1906, Compatriot Hahn has suggested to the current President General that he thought it would be appropriate if the NSSAR participated in the Grand Opening of the Theodore Roosevelt Presidential Library. It certainly ties to the NSSAR 250th Anniversary of the American Revolution Recognition Program.

We the People of the United States, in order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America.



THE AMERICAN CREED by William Tyler Page

Accepted by House of Representatives, April 3rd, 1918

I believe in the United States of America as a government of the people, by the people, for the people; whose just powers are derived from the consent of the governed; a democracy in a republic; a sovereign Nation of many sovereign States; a perfect Union, one and inseparable; established upon those principles of freedom, equality, justice and humanity for which American patriots sacrificed their lives and fortunes.

I therefore believe it is my duty to my country to love it; to support its Constitution; to obey its laws; to respect its Flag, and to defend it against all enemies.
